ACTMEP is into the business of offering Skills Trainings and Certification to job seekers in Engineering and other allied fields by offering various skill oriented courses. ACT offers courses that are relevant to engineering students in colleges and equips them with right skills. And that Gokula Krishna College of Engineering, Sullurpet is an Engineering College across all disciplines, ACT is partnering with the Gokula Krishna College of Engineering, Sullurpet to provide the required skills to the GKCE students and other college students in and around Sullurpet by offering various training courses.

Terms of the Agreement

- The college appoints ACTMEP as a partner for providing the following skill courses as mentioned below:
 1. HVAC Design & Drafting Course
 2. Electrical Design & Drafting Course
 3. Revit MEP Course
 4. Python Course

1. STRUCTURING OF TRAINING PROGRAMS

- The HVAC Design & Drafting training program will be of a span of 60 hours.
- The Electrical Design & Drafting training program span of 60 hours
- The Python training program span of 140 hours
- The course will be handled by an ACTMEP Certified Trainers. One Trainer will be dedicated who will manage the schedule of the training sessions. Number of trainers will be depended on the number of students.
- Complete training modules specifically created for College Students by ACTMEP taking into account the needs the industry from time to time.
- The Trainers will ensure that all students are given the Importance to help them with the skill sets required.
- The Trainers will be conducting the sessions at the college premises at the dedicated room provided.



2. DELIVERABLES FROM ACT

- To provide trainers required for running the course. Provide certified trainers who are confident, good in communication and follow the rules of the company.
- ACTMEP shall insist the trainer engaged in the college to follow the rules and regulations of the college.
- Ensure the attendance of the trainer and ensure that he /she report to work, as scheduled by the college, unless he is prevented from doing so by illness, injury, or other reason approved by the Principal or the Coordinator of the college.
- In the event a particular trainer being unable to provide service for more than 15 days on account of any reason, ACTMEP will send a replacement for such days till the originally deputed trainer resumes service. The holiday list maintained by the college will be applicable to the trainer as well.
- The trainer will be an employee of ACTMEP and the College will have no responsibility in payment of Salary or other benefits to the trainer.
- In case of any complaint against the trainer including misconduct/misbehaviour, the college shall immediately inform ACTMEP and both the parties shall together investigate the same and take appropriate remedial measures.
- Provide all training materials required, such as course manual, workbooks etc. If there are any other requirements, the same will be taken care by ACTMEP
- ACTMEP will also help in the placement of these students. ACTMEP will assist in scheduling five interviews guaranteed for every student who got trained and certified. A certificate is awarded upon completion of the assessment.

3. OBLIGATIONS FROM THE COLLEGE

10. TERM AND TERMINATION

- The term of the agreement shall initially be for a period of 2 years. On completion of the said term, parties may mutually agree to renew the term of the agreement to such period as mutually decided by the Parties. During the term of this agreement, either party can terminate the agreement by providing three months prior notice to the other Party, however, if the termination is at the instance of the college, for any reasons other than below, the college may consider some percentage of payment to ACT after mutual understanding.

Either party may from time to time specify as its address for purposes of this Agreement any other address upon giving ten (10) days written notice thereof to the other party.

12. RELATIONSHIP OF PARTIES.

- ACT shall be an independent contractor. 15. REPRESENTATIONS

16. INDEMNITY

- The College shall indemnify and hold harmless ACT, its directors, officers, employees, and agents for any liability and costs arising from any unforeseen incidents or accidents, claims damages that may happen due to any act in relation to the performance of this agreement.

17. ARBITRATION

- In the event of any dispute or difference arising between the parties hereto or as to the rights and obligations under this agreement or as to any claim, monetary or otherwise of one party against the other or as to the interpretation and effect of any terms and conditions of this agreement, such dispute or difference shall be referred to Arbitration of a common Arbitrator if agreed upon otherwise to three Arbitrators, one to be appointed by each of the parties to this agreement and third by the arbitrators thus appointed by the parties and such Arbitration shall be governed by the Indian Arbitration & Conciliation Act, 1996. The venue for such Arbitration shall be in Chennai, India.

18. GOVERNING LAW AND JURISDICTION:

- The laws of India shall govern this Agreement. The parties will attempt in good faith to resolve any controversy or claim arising out of or relating to this Agreement promptly by negotiations first between the principal, and the relationship manager of ACT. If it is not so resolved it shall be referred for arbitration. All legal action relating to this

- This Agreement is made under and shall be governed by and construed for all purposes in accordance with the laws of India and subject to arbitration, courts at Bengaluru shall have exclusive jurisdiction.

- Nothing in this Agreement (or any of the arrangements contemplated by it) shall be deemed to constitute a partnership between the Parties, nor, except as may be expressly set out in it, constitute any Party as the agent of another Party for any purpose, or entitle any party to commit or bind another Party in any manner.

- d) To facilitate the training for students GF -2, 48-8-4, Sai Balaji Appartments, Dwarakanagar, Lane Behind Boy London Showroom, Visakhapatnam - 530016

3. Proposed Modes of Collaboration

ALBRIGHT TECHNOLOGY and GKCE propose to collaborate through the following:

- b) Any other appropriate mode of interaction agreed upon between ALBRIGHT TECHNOLOGY and GKCE.
- c) Any specific campaigns of collaborations on various marketing activities would be decided mutually after discussing the financial projections.

A Specific plan will be worked out by the institutions depending upon availability of resources. A specific agreement will be entered into for each activity.

4. Terms and Conditions

- e) Both institutes agree to help, identify and invite the faculty members and researches from other institutes to participate in conferences, workshops and short-term courses.
- f) This MOU may be amended, renewed and terminated by mutual written agreement of the institutes at any time.
- g) Either Institute shall have the right to terminate this MOU upon 60 days prior written notice to the other Institute.

5. Confidentially

- a) The ALBRIGHT TECHNOLOGY and the GKCE agree to hold in confidence all information/data designated by the institutes as being confidential which is obtained from either institute or created during the performance of the MOU and will not disclose the same to any third party without written consent of the other institute.
- b) The above confidential clause under this MOU excludes the information/data possesses by either institute before entering into this MOU or independently developed and/or information already available through public domain.





1. Objectives of MOU

4. Confidentiality

Both Takshila VLSI and College will designate persons who will have responsibility for coordination and implementation of this agreement.









7. Intellectual Property Rights
